Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the constituent corporation is FUJIFILM Medical Systems U.S.A., Inc., a New York corporation, and the name of the corporation being merged into this constituent corporation is FUJIFILM Healthcare Americas Corporation, a Delaware corporation.

SECOND: The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8, Section 252 of the Delaware General Corporation Law.

THIRD: The name of the surviving corporation is FUJIFILM Medical Systems U.S.A., Inc., a New York corporation, which shall be changed to "FUJIFILM Healthcare Americas Corporation" on the effective date of this merger set forth below.

FOURTH: The Certificate of Incorporation of FUJIFILM Medical Systems U.S.A., Inc. as amended to change the name of the company to "FUJIFILM Healthcare Americas Corporation" shall be the Certificate of Incorporation of the surviving corporation.

FIFTH: The merger is to become effective at 12:01 am (Eastern time) on October 1, 2021.

SIXTH: The Agreement and Plan of Merger is on file at 81 Hartwell Avenue, Suite 300, Lexington, Massachusetts 02421, an office of the surviving corporation.

SEVENTH: A copy of the Agreement and Plan of Merger will be furnished by the surviving corporation on request, without cost, to any stockholder of the constituent corporations.

EIGHTH: Pursuant to Section 252(d) of the Delaware General Corporation Law, the surviving corporation hereby agrees that it may be served with process in the State of Delaware in any proceeding for the enforcement of any obligation of any constituent corporation of the State of Delaware, as well as for enforcement of any obligation of the surviving corporation arising from this merger, including any suit or other proceeding to enforce the right of any stockholder as determined in appraisal proceedings pursuant to the provisions of Section 262 of the Delaware General Corporation Law, and hereby irrevocably appoints the Secretary of State of the State of Delaware as its agent to accept service of process in any such suit or other proceedings. 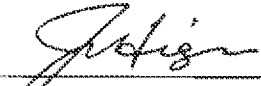

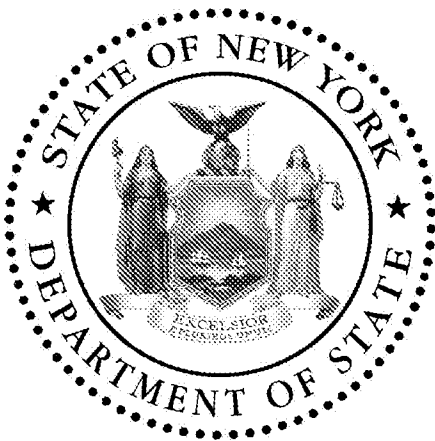

It is hereby certified, upon behalf of each of the constituent corporations herein named, as follows:

FIRST: The Board of Directors of each of the constituent corporations has adopted an agreement and plan of merger setting forth the terms and conditions of the merger of such corporations.

SECOND: The name of the domestic constituent corporation, which is to be the surviving corporation, is FUJIFILM Medical Systems U.S.A., Inc. The name under which the surviving corporation was formed is Pyne X-Ray Corp., and the date upon which the certificate of incorporation of the surviving corporation was filed by the Department of State of the State of New York is October 28, 1963.

THIRD: The name of the foreign constituent corporation, which is being merged into the surviving corporation, is FUJIFILM Healthcare Americas Corporation. The name under which the merging corporation was formed is Hitachi Medical Systems America, Inc. The jurisdiction of the incorporation of the merging corporation is the State of Delaware, and the date of the incorporation of the merging corporation therein is April 14, 1989. The Application for Authority in the State of New York of the merging corporation to transact business as a foreign corporation therein was filed by the Department of State of the State of New York on November 15, 1995.

FOURTH: The designation and number of outstanding shares of the only class of capital stock of the merging corporation, all of which shares are entitled to vote, and the designations and numbers of outstanding shares of all classes of capital stock of the surviving corporation, only Class A Common Stock shares of which shares are entitled to vote, as set forth in the agreement and plan of merger, are as follows:

FIFTH: The certificate of incorporation of the surviving corporation as now in force and effect shall be the certificate of incorporation of the surviving corporation, except that Paragraph FIRST thereof, relating to the name of the corporation, is hereby amended so as to read in its entirety as follows upon the effective date of the merger set forth below:

“FIRST: The name of the corporation is
FUJIFILM Healthcare Americas Corporation.”

SIXTH: The merger herein certified was authorized in respect of the surviving corporation by the written consent of the holder of all of the outstanding shares of capital stock of the surviving corporation entitled to vote on the agreement and plan of merger, which written consent has been given in accordance with Section 615 of the New York Business Corporation Law. Written notice has been given as and to the extent required by Section 615 of the New York Business Corporation Law.

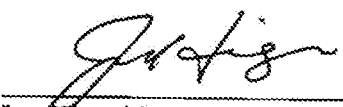
