TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 15, 2021, by VARAGON CAPITAL PARTNERS AGENT, LLC, as administrative agent (“Administrative Agent”) for the Secured Parties. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Fortis Solutions Group, LLC, a Virginia limited liability company (the “Grantor”), and Administrative Agent are parties to that certain Trademark Security Agreement dated as of December 15, 2017 (the “Security Agreement”), pursuant to which Grantor granted a security interest to Administrative Agent in certain Trademark Collateral as security for certain obligations owing by Grantor to Administrative Agent, including the Trademarks set forth on Schedule A hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on December 15, 2017, at Reel 6229 Frame 0853;

WHEREAS, Grantor has requested that Administrative Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral, including but not limited to the following:

the registered Trademarks (as defined in the Security Agreement) and Trademarks for which applications are pending in the United States Patent and Trademark Office set forth in Schedule A hereto.

2. Administrative Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent’s right, title and interest in and to the Trademark Collateral.
