ASSIGNMENT

WHEREAS, Chi Jung Chu (hereinafter referred to collectively as “ASSIGNOR”) is the owner of the trademark “BLACKNBIANCO” in classes 009 and 025 with Serial No. 87605102, filed on September 12, 2017, and the trademark was then registered with Registration No. 5667249.

WHEREAS, the above-referenced trademarks “BLACKNBIANCO” is referred to as TRADEMARK;

NOW THEREFORE, in the receipt of valuable consideration which is hereby acknowledged, ASSIGNOR does hereby sell, assign and set over to ASSIGNEE:

(i) the entire right, title, interest and goodwill in and to the TRADEMARK that ASSIGNOR has or may have, and trademark claiming priority therefrom, and all United States Trademarks which may be granted thereon and all priority rights under all available International Agreements, Treaties and Conventions for the protection of intellectual property in its various forms in every participating country; and

(ii) any and all claims and demands that ASSIGNOR may have against any firm, person or corporation relating to the TRADEMARK including but not limited to, any claim of infringement or claim of provisional rights, whether heretofore or hereafter accrued, together with the right to retain for ASSIGNEE any and all sums that ASSIGNEE may obtain or recover as a result of the assertion or enforcement of any such claim or demand; and

ASSIGNOR hereby authorize and requests the United States Patent and Trademark Office, and any officials of foreign countries whose duty it is to issue trademark on application as aforesaid, to issue all trademark to ASSIGNEE in accordance with the terms of this Assignment;

ASSIGNOR hereby covenant that ASSIGNOR has full right to convey the entire interest, and that ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith;
