NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This Notice of Grant of Security Interest in Trademarks (this "Trademarks Notice of Grant") is made as of October 15, 2021 by and among the Notes Parties party hereto (the "Grantor"), in favor of U.S. BANK NATIONAL ASSOCIATION, in its capacity as collateral agent for itself and the other Secured Parties (together with its successors and assigns in such capacity, the "Grantee").

WHEREAS, the Grantor holds the right, title and interest in and to the trademarks and service marks listed on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, the Grantor has entered into the Pledge and Security Agreement, dated October 15, 2021, by and among the Notes Parties party thereto and the Grantee (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"); and

WHEREAS, pursuant to the Security Agreement, the Grantor has pledged, collaterally assigned, and granted to the Grantee for the benefit of the Secured Parties, a continuing security interest in all Intellectual Property of the Grantor including (i) the Trademarks, (ii) all extensions, modifications and renewals thereof, (iii) the goodwill of the Grantor's business symbolized by the foregoing or connected therewith, (iv) all proceeds thereof, including any income, license fees, royalties, damages, and payments now and hereafter due or payable under and with respect thereto, including payments under all licenses entered into in connection therewith and damages and payments for past, present or future infringements, dilutions and other violations thereof, (v) the right to sue for past, present and future infringements, dilutions and other violations thereof, and (vi) all of the Grantor's rights corresponding thereto throughout the world (the "Collateral"), to secure the payment performance and observance, as the case may be, of all of the Notes Obligations (as defined in the Indenture).

NOW, THEREFORE, as collateral security for the payment, performance and observance, as the case may be, of all of the Notes Obligations, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor does hereby pledge, and collaterally assign to the Grantee (and its agents and designees), and grant to the Grantee (and its agents and designees), for the benefit of the Secured Parties, a continuing security interest in the Collateral.

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

This Trademarks Notice of Grant may be executed in any number of counterparts


