**RELEASE OF CONFIRMATORY GRANT OF
SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS (the "**Release**") is effective as of the 12th day of August, 2021, by and between:

ERSKINE ATTACHMENTS, LLC, a Minnesota limited liability company, having an address of 5181 State Highway 29 North, Alexandria, Minnesota 56308 ("**Assignor**"), and

ASSOCIATED BANK, NATIONAL ASSOCIATION, in its capacity as Administrative Agent for the Lenders, having an address of 1200 Hansen Road, Green Bay, Wisconsin 54304 ("**Assignee**").

W I T N E S S E T H:

A. Assignor and Assignee, among others, entered into that certain Credit Agreement dated as of July 17, 2020 (the "**Credit Agreement**").

B. Assignor and Assignee, among others, are parties to that certain Pledge and Security Agreement dated as of July 17, 2020 (the "**Security Agreement**"), pursuant to which Assignor pledged, assigned and granted a security interest in favor of Assignee in certain Collateral (as defined therein).

C. Assignor and Assignee are parties to that certain Confirmatory Grant of Security Interest in Trademarks dated as of July 17, 2020, which was recorded with the United States Trademark and Trademark Office ("**PTO**") on July 20, 2020, at Reel 7002, Frame 0619 (the "**Trademarks Assignment**").

D. Assignor has satisfied all of the Obligations under the Credit Agreement and the Security Agreement and requested that the Assignee terminate and release its security interests in and liens on the Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) **Definitions**. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Credit Agreement or the Security Agreement or the Trademarks Assignment, as the case may be.

2) **Termination and Release of Security Interest**. The Assignee hereby terminates, releases, and discharges its security interest in and liens on the Collateral, including, without limitation, the Trademarks listed on Exhibit A hereto, and the Assignee hereby assigns and transfers to the Assignor, without representation, warranty or recourse, all of the Assignee's right, title and interest in and to such Trademarks, effective as of the date set forth above.

IN WITNESS WHEREOF, the Assignee has executed this Release effective as of the date written above.


