## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("Assignment") is made, entered into, and effective as of this 19 day of October, 2021 (the "Effective Date"), by and between MICHAEL WOLFE ("Assignor"), an individual and Indiana resident, and CHAMPIONS BOWLING PRODUCTS, LLC ("Assignee"), an Indiana limited liability company with an address of 6015 Huntington Creek Drive, Floyds Knobs, Indiana 47719.

### RECITALS

A. Assignor owns U.S. Reg. No. 6,200,677 (the "Registration") for the trademark CHAMPIONS BOWLING PRODUCTS (the "Mark").

B. Assignor now desires to transfer and assign to Assignee, and Assignee desires to acquire from Assignor, all of Assignor's rights, title, and interests in and to the Mark and the Registration.

### AGREEMENT

NOW, THEREFORE, in consideration of the foregoing, and the mutual promises and covenants contained in this Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. **ASSIGNMENT.** Assignor hereby irrevocably transfers and assigns to Assignee, and Assignee hereby accepts from Assignor, the Mark and the Registration, all of Assignor's rights, title, and interests in and to the Mark and the Registration, including, without limitation, any and all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law, any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing, and any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the Effective Date, together with the goodwill associated with and symbolized by the Mark.

2. **COVENANT.** Assignor agrees, without the need for further consideration, to cause such other lawful acts to be performed and to cause such further assignments and other lawful documents to be executed, as Assignee may from time to time reasonably request, to effect fully this Assignment and to permit Assignee to be duly recorded as the legal and record owner of each of the rights hereby conveyed.

3. **GOVERNING LAW.** This Assignment, and any subsequent amendments or modifications to this Assignment, shall be governed by and construed in accordance with the laws of the state of Indiana, without regard to its or any other jurisdiction's conflict of laws rules or principles.

4. **COUNTERPARTS.** This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

5. **SUCCESSORS AND ASSIGNS.** This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors, heirs, and assigns.

6. **ENTIRE AGREEMENT.** This Assignment constitutes the entire understanding and agreement between the parties with regard to the subject matter of this Assignment, and this Assignment supersedes and replaces all previous representations, proposals, discussions, communications, and prior agreements between the parties relating to the subject matter of this Assignment, whether oral or written. The language of all parts of this Assignment shall in all cases be construed as a whole, according to its fair meaning, and not strictly for or against either of the parties.
