RELEASE OF SECURITY INTEREST

This Release of Security Interest (“Release”) is made as of October 18, 2021 by COMERICA BANK, a Texas Banking Association (“Bank”), in favor of ClosingCorp Inc. a Delaware corporation (“Debtor”).



Bank hereby terminates, releases, and discharges all of its security interest in, to and under the Trademark Collateral (as defined in the Security Agreement), including the Trademarks identified in Schedule A, terminates the Security Agreement, and reassigns to Debtor, without warranty of recourse, any and all interest held by Bank in, to and under all of the Trademark Collateral.
