**MEMORANDUM AND NOTICE OF SECURITY INTEREST

Unless and until an Event of Default (as defined in the Agreement) occurs and is continuing, Debtor shall retain the legal and equitable title to the Trademarks, and shall have the right to use and register the Trademarks, as applicable, in the ordinary course of the business of Debtor. The terms and conditions of the aforementioned security interest are contained in that certain Joinder and Second Amendment to Financing and Security Agreement of even date herewith (the "Agreement"), between Debtor and Lender, as security for the Obligations under and as set forth in the Agreement and other agreements referred to therein. Nothing contained herein shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Lender may have in any other collateral described in the Agreement or otherwise.
