RELEASE OF SECURITY INTEREST IN TRADEMARKS AGREEMENT

This RELEASE OF SECURITY INTEREST IN TRADEMARKS AGREEMENT (“Release”) is made as of the 20th day of October, 2021, by and between Keybank National Association, 100 Federal Street, Boston, MA 02110, in its capacity as agent for itself and on behalf of the Lenders (as defined in the Security Agreement) (the “Releasing Party”), and TPS Parking Management, LLC (f/k/a PRG Parking Management, L.L.C.), a Delaware limited liability corporation having its principal place of business at 200 West Monroe Street, Chicago, IL 60606 (the “Borrower”).

WITNESSETH

WHEREAS, the Releasing Party and the Borrower are parties to a certain Intellectual Property Security Agreement, dated as of December 9, 2011 (the “Security Agreement”), wherein the Borrower granted the Releasing Party a security interest in the trademarks listed on Schedule A attached hereto (the “Trademarks”) and the goodwill of the business connected with the use of and symbolized by the Trademarks existing as of the date of the Security Agreement or thereafter created or acquired; and


WHEREAS, the Borrower requests a specific release of the security interest recorded against the Trademarks, and the Releasing Party desires to grant to Borrower a specific release of its security interests recorded against the Trademarks.

NOW THEREFORE, for the sum of \$10.00 and other good and valuable consideration previously tendered by the Borrower, the receipt and sufficiency of which are hereby acknowledged, the Releasing Party does hereby reassign, relinquish and release forever to Borrower all right, title and interest of any nature whatsoever which the Releasing Party as a Secured Party holds in the Trademarks listed on Schedule A attached hereto and associated common law rights and goodwill appurtenant thereto, and any subsequently created rights under the Security Agreement, and further agrees that it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights.
