PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of October 14, 2021 (this “Release”), is executed by RUNWAY GROWTH FINANCE CORP., as collateral agent (in such capacity, “Agent”), in favor of SNAGAJOB.COM, INC., a Delaware corporation (“Pledgor”), as follows:


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

1. Agent hereby releases, discharges, cancels and terminates its security interest in and continuing lien on the Released Collateral, including the Trademarks set forth on Schedule A attached hereto, and re-assigns, re-transfers and re-conveys to Pledgor any and all right, title or interest Agent may have in and to Pledgor’s Released Collateral.
2. Agent agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as Pledgor may reasonably request, in order to perfect, confirm or evidence such release, at the sole cost and expense of Pledgor.
3. Agent represents and warrants that it has the full power and authority to execute this Release.
4. Agent authorizes and requests the Trademark Division of the United States Patent and Trademark Office, and any other appropriate domestic and foreign authorities as may be necessary or desired by Pledgor, to evidence this Release.


