**TERMINATION AND RELEASE OF
SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination and Release"), dated as of October 12, 2021 is made by Cambridge Trust Company (the "Lender") in favor of LiveProcess Corporation, a Delaware corporation, located at Suite 2300, 235 Peachtree Street NE, Atlanta, Georgia 30303 (the "Borrower").

WITNESSETH:

WHEREAS, pursuant to the Loan and Security Agreement, dated as of September 15, 2017 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), between the Borrower and the Lender;

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated as September 15, 2017 (the "IP Security Agreement"), a lien on and security interest (collectively, the "Security Interest") was granted by the Borrower to the Lender in certain collateral, including the Patents and Trademarks;

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office on September 25, 2017 at Reel/Frame (i) 6160/0306 and (ii) 043993/0452.

WHEREAS, the Lender now desires to terminate and release the entirety of its Security Interest in the Patents and Trademarks, including those listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the IP Security Agreement or the Credit Agreement, as applicable.
2. Release of Security Interest. The Lender hereby terminates, releases and discharges any and all Security Interest in the Patents and Trademarks (including those listed on Schedule 1 hereto), and any right, title or interest of the Lender in such Patents and Trademarks shall hereby cease and become void.
3. Recordation. The Lender authorizes the Borrower and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Borrower's expense.
4. Further Assurances. At the request and sole expense of the Borrower, the Lender agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary or reasonably requested by the Borrower to carry out the purposes of this Termination and Release.
