## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of October 21, 2021 is made by BANK OF AMERICA, N.A., as Lender (as defined below), in favor of ARCHITECTURAL GRANITE & MARBLE, LLC, a Delaware limited liability company ("AG&M"), and PENTAL GRANITE AND MARBLE, LLC, a Washington limited liability company ("Pental" and together with AG&M, individually and collectively, the "Grantor"). Unless otherwise defined herein or the context otherwise requires, terms used in this Release shall have the meanings assigned to such terms in the Assignment (as defined below).

**WHEREAS**, pursuant to that (i) certain Amended and Restated Loan, Security and Guaranty Agreement, dated as of June 28, 2018 (as it has and may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement") among AG&M, Pental and Select Interior Concepts, Inc., a Delaware corporation ("Topco", together with Pental and AG&M, individually and collectively, "Borrower"), Architectural Surfaces Group, LLC, a Delaware limited liability company ("AG&M Parent"), Residential Design Services, LLC, a Delaware limited liability company ("L.A.R.K. Parent"), AG Holdco (SPV) LLC, a Delaware limited liability company ("AG SPV") and SIC Intermediate, Inc., a Delaware corporation ("SIC", and together with Borrower, AG&M Parent, AG SPV and L.A.R.K. Parent, each individually, an "Obligor" and collectively, the "Obligors") and Bank of America, N.A., a national banking association (the "Lender") and (ii) certain Amended and Restated Assignment for Security - Trademarks, dated as of June 28, 2018 (the "Assignment"), executed by each Grantor in favor of the Lender, the Grantors pledged, conveyed, sold, assigned, transferred, set over unto the Lender and granted to the Lender a continuing security interest in all of the Grantors' right, title and interest in, to and under the Collateral, including the Trademarks listed on Schedule 1 attached hereto (collectively, the "Trademark Collateral"); and

**WHEREAS**, the security interest in the Trademark Collateral pledged and granted by the Grantor to the Lender under the Assignment was recorded at the United States Patent and Trademark Office on July 2, 2018, at Reel 6370, and Frame 0159; and

**WHEREAS**, the Lender has agreed to terminate, release and discharge its security interest and lien on the Trademark Collateral; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

1. The Lender hereby (i) terminates the Assignment, and (ii) releases and discharges all of its mortgages, liens and security interests in all of any Grantor's right, title and interest in, to and under the Trademark Collateral, which had been granted under the Assignment and hereby reassigns and conveys any and all such right, title and interest (if any) that the Lender may have in the Trademark Collateral to the applicable Grantor.

2. The Lender authorizes and requests that the United States Commissioner for Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Release.

3. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.
