TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (the “Release”) is made as of October 19, 2021, by BMO HARRIS BANK N.A., as Administrative Agent (“Agent”) for the Secured Creditors. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, BLUSKY RESTORATION CONTRACTORS, LLC, a Delaware limited liability company (the “Grantor”), and Agent are parties to that certain Trademark Security Agreement dated as of August 14, 2018 (the “Security Agreement”), pursuant to which Grantor granted a security interest to Agent in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule A hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on August 14, 2018, at Reel 6412 Frame 0774;

WHEREAS, Grantor has requested that Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its continuing security interest in all of Grantor’s right, title and interest in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof (as set forth on Schedule A attached hereto), and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the “Trademark Collateral”);

2. Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in and to the Trademark Collateral; and


3. Agent hereby authorizes the recordation of this Release with the USPTO or any similar office or agency within or outside the United States at Grantor’s expense.
