Remedy Applications Inc. (the "*Corporation*"), a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "*General Corporation Law*"),

DOES HEREBY CERTIFY:

FIRST. The name of the Corporation is Remedy Applications Inc., and the Corporation was originally incorporated pursuant to the General Corporation Law on June 6, 2019, under the name Remedy Applications Inc. (the "*Certificate of Incorporation*").

SECOND. This Certificate of Amendment to the Certificate of Incorporation (this "*Certificate*") was duly adopted by the Corporation's directors and stockholders in accordance with the applicable provisions of Sections 228 and 242 of the General Corporation Law.

THIRD. The First Article of the Certificate of Incorporation is hereby amended and restated in its entirety to read as follows:

"FIRST: The name of the corporation is CareHive Health Inc. (the "*Corporation*").

FOURTH. All other provisions of the Certificate of Incorporation shall remain in full force and effect.

FIFTH. This Certificate shall be effective on and as of the date of filing of this Certificate with the Secretary of State of the State of Delaware.
