TRADEMARK ASSIGNMENT

This Trademark Assignment ("*Assignment*"), effective as of August 1, 2021 ("Effective Date"), is made by and between Plains Tire & Battery Co., Inc., a Wyoming corporation, with an address at 895 North Main, Logan, Utah 84321 ("*Assignor*") and Les Schwab Warehouse Center, LLC, an Oregon limited liability company, with an address at 20900 Cooley Rd., Bend, Oregon 97701 ("*Assignee*");

WHEREAS, Assignor owns all rights, title, and interest in and to the trademark as set forth in **Schedule A**, all common law rights appurtenant thereto, as well as all the goodwill associated therewith (hereinafter collectively referred to as the "*Trademark*");

WHEREAS, Assignee desires to purchase, acquire and accept Assignor's rights, title, and interest in and to the Trademark;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor does hereby sell, assign, and transfer, to Assignee rights, title, and interest in and to the Trademark identified in Schedule A, including the pending application for the foregoing, and the goodwill business associated therewith. This agreement shall inure to the benefit of and be binding upon Assignee and Assignor and their respective heirs, successors, and assigns.
2. Assignor hereby warrants that it has not pledged, mortgaged, assigned, transferred, or otherwise granted any rights or interests in the Trademark to any third party.
3. Assignor agrees to execute all instruments and documents and do such additional acts as Assignee may deem necessary or desirable to effect, evidence, record, and perfect the assignment and recordation of the rights being assigned hereunder. If Assignee is unable for any reason whatsoever to secure Assignor's signature to any document it is entitled to under this Assignment, Assignor hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents, as its attorneys-in-fact, with full power of substitution to act for and on their behalf and instead of Assignor to execute and file any such document or documents and to do all other lawfully permitted acts to further the purposes of the foregoing with the same legal force and effect as if executed by Assignor.
4. The parties may execute this agreement in counterparts, each of which together shall be deemed the complete and fully executed agreement.
