**TRADEMARK ASSIGNMENT**

WHEREAS, Assignee is desirous of acquiring all Assignor's right, title, and interest in and to the Marks and Applications and Registrations, and Assignor is desirous of assigning to Assignee all Assignor's right, title, and interest in and to the Marks and Applications and Registrations;

NOW, THEREFORE, for good and valuable consideration, as set forth herein by and between the Parties pursuant to the asset purchase agreement between Zoetop Business Co., Limited and Shenhe International Holding Group Co., Limited, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor hereby assigns to Assignee all Assignor's right, title, and interest in and to the Marks and Applications and Registrations, together with the goodwill of the business symbolized by the Marks and Applications and Registrations, the business associated with the marks, and all rights to damages and profits, due or accrued, arising out of past infringements of said Marks and Applications and Registrations and the right to sue for and recover the same.

2. Assignor shall promptly, upon the request of Assignee, execute such other documents and/or instruments of assignment, transfer and conveyance as Assignee may reasonably request to permit Assignee to record the assignment made by this instrument or any other documents Assignee may reasonably deem necessary or advisable to effectuate the terms and intent of this Trademark Assignment.


