**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of October 22, 2021, and made by Cortland CAPITAL MARKET SERVICES LLC, as the collateral agent ("Agent") for itself and the FILO Secured Parties ("Grantee") to THE HERCULES TIRE & RUBBER COMPANY, a Connecticut corporation (the, "Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of December 21, 2018 made by Grantor in favor of Grantee (the "IP Security Agreement"), security interests were granted by Grantor to and in favor of Grantee in and to all of the Grantor's individual rights, title and interest in and to the Intellectual Property (as hereinafter defined);

WHEREAS, the IP Security Agreement were recorded with the United States Patent and Trademark Office on January 17, 2019 at Reel/frame 6528/0875; and

WHEREAS, Grantee now desires to terminate and release the IP Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. Unless otherwise defined herein, the capitalized terms used herein which are defined in the IP Security Agreements or, by reference, the underlying Security Agreements shall have the meanings specified in the IP Security Agreement. The term "Intellectual Property," as used herein, shall mean Trademarks constituting IP Collateral as defined in the IP Security Agreement, including those listed on Schedule A attached hereto.


2. Release of Security Interest. Grantee hereby terminates the IP Security Agreement and hereby absolutely and unconditionally terminates, releases, reconveys and forever discharges its security interest and any other interest in the Intellectual Property. Grantee further absolutely and unconditionally releases all of its right, title and interest in and to any and all property, assets and collateral secured, hypothecated or pledged under or by the IP Security Agreement.

3. Further Assurances. Grantee shall take all further actions, and provide to Grantor and its successors, assigns or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Termination.


