## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of October 19, 2021, by ALLY BANK, as Agent (the "Agent"), in favor of USALCO, LLC, a Maryland limited liability company ("Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below), whether directly therein or by reference to another agreement.

### WITNESSETH:

WHEREAS, Grantor and Agent are party to that certain Trademark Security Agreement, dated as of June 1, 2020 (the "Trademark Security Agreement"), which was duly recorded on June 5, 2020 at Reel 6954 Frame 0706 in the United States Patent and Trademark Office;

WHEREAS, Grantor has requested that the Agent release its continuing security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantor; and

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Agent hereby releases the security interest in all of Grantor's right, title and interest in and to the following:

a. all of its registrations for Trademarks and applications to register Trademarks and Trademark Intellectual Property Licenses to which it is a party, including the United States trademark and service mark registrations and applications referred to on Schedule I;

b. all goodwill of the business connected with the use of, and symbolized by each Trademark; and


c. all products and proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future (i) infringement of any Trademark, including, the right to receive damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License.

2. The Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademarks and the Trademark Collateral and hereby terminates the Trademark Security Agreement.

The liens and security interests evidenced by the Trademark Security Agreement, and any other right, title or interest granted to the Agent in the trademarks set forth on Schedule 1 attached hereto is hereby terminated, cancelled and released, without representation or warranty, and the Agent hereby re-assigns, without representation or warranty, to the Grantor any right, title or interest it may have in or to any of the trademarks set forth on Schedule 1.

The Agent authorizes the recordation of this Notice of Release of Security Interest in Trademarks with the United States Patent and Trademark Office, at Grantor's expense.





