THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 21, 2021, by Zions Bancorporation N.A. ("Grantee"), pursuant to the Security Agreement (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement.

WITNESSETH:

WHEREAS, Honeyville, Inc. ("Grantor") is a party to that certain Memorandum and Notice of Security Interest In Intellectual Property, dated as of April 21, 2020 (the "Security Agreement"), pursuant to which Grantor granted a security interest in favor of Grantee in certain trademarks, including the trademarks set forth on Schedule I hereto ("Trademarks"), and Trademark Collateral (as defined below) as security for the Secured Obligations; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on April 21, 2020 at Reel 006920, Frame 0193.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases, discharges, terminates and cancels its security interest in, to and under the following (collectively the "Trademark Collateral");

(a) all Trademarks and the applications and registrations thereof owned by Grantor, including, without limitation, those referred to on Schedule 1 hereto;

(b) the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof; and


(c) all proceeds of (a) and (b) above, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof.
