**CORRECTIVE RELEASE  
(REEL/FRAME 6285/0520)**

This CORRECTIVE RELEASE (this "Corrective Release"), dated as of October 25, 2021 (the "Effective Date"), is made by BANK OF AMERICA, N.A., as administrative agent (in such capacity, the "Agent") pursuant to the Credit Agreement, in favor of HEALTH IN MOTION, LLC, a Delaware limited liability company ("Health").

Reference is hereby made to that certain Trademark Security Agreement, dated as of March 6, 2018 (the "Trademark Security Agreement"), among the Agent and the grantors listed on the signature pages thereto (together with Health, collectively, the "Grantors"), pursuant to which Health purported to grant to the Agent a security interest in and to, among other collateral referenced therein, the Trademarks as listed on Schedule I attached hereto (such Trademarks and any such other collateral relating to the Trademarks, collectively, the "2018 Trademarks"). The Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 07, 2018 at Reel/Frame 6285/0520.

The Agent does not now own, has never owned, and, on the date the Trademark Security Agreement was executed, did not own, any security interest in the 2018 Trademarks. The 2018 Trademarks were inadvertently included in the Trademark Security Agreement in error. In order to correct such error, the Agent is executing this Corrective Release, at the request of Health.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Trademark Security Agreement.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates, withdraws and cancels any and all of its alleged lien on and security interest in and to the 2018 Trademarks.
3. Limitation. This Corrective Release is applicable only and solely with respect to the 2018 Trademarks and to no other collateral arising under the Trademark Security Agreement (the "Retained Collateral"). The Agent retains all security interests, liens, rights, titles and interests pledged and granted to the Agent under the Trademark Security Agreement with respect to all such Retained Collateral, and the Agent's security interest, liens, rights, titles and interests in such Retained Collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Corrective Release.
