**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of October 19, 2020, by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, a United States national banking association (the “Agent”) in favor of **HUB CONSTRUCTION SPECIALTIES, INC.**, a California corporation with an address at 379 South I Street, San Bernadino, California 92410 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated February 21, 2020 (the “Trademark Security Agreement”) with Agent, notice of which was recorded on February 21, 2020 by the United States Patent and Trademark Office at Reel 6869, Frame 0717.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Agent, in and to all of Grantor’s Trademark Collateral, including without limitation the Trademarks listed in Schedule A.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby, without recourse and without representation or warranty of any kind (either express or implied), releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, including and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
