**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of October 19, 2020, by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, a United States national banking association (the “Agent”) in favor of **WILLIAMS EQUIPMENT & SUPPLY COMPANY**, a Tennessee corporation with an address at 3821 New Getwell Road, Memphis, Tennessee 38118, **WILLIAMS EQUIPMENT & SUPPLY COMPANY OF LOUISIANA**, a Louisiana Corporation with an address at 1813 Barton Drive, Shreveport, Louisiana 71107, **SBP ACQUISITION, LLC**, an Iowa limited liability company with an address at 2205 Bell Avenue, Corporate Office, Des Moines, Iowa 50321, **BEST MATERIALS LLC**, an Arizona limited liability company with an address at 2851 W. Indian School Road, Suite 100, Phoenix, Arizona 85017, **BROCK WHITE COMPANY, LLC**, a Wyoming limited liability company with an address at 2575 Kasota Avenue, St. Paul, Minnesota 55108, **MASONPRO, INC.**, a Michigan corporation with an address at 43300 Seven Mile Road, Northville, Michigan 48167, and **CARTER-WATERS LLC**, a Delaware limited liability company with an address at 6803 West 64th Street, Suite 300, Overland Park, Kansas 66202 (each, a “Grantor” and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into a certain trademark security agreement dated October 1, 2019 (the “Trademark Security Agreement”) with Agent, notice of which was recorded on October 1, 2019 by the United States Patent and Trademark Office at Reel 6760, Frame 0981.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Agent, in and to all of each such Grantor’s Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


