NOTICE OF SECURITY INTEREST
U.S. TRADEMARKS

WHEREAS, Merlot Vango Tarping Solutions LLC, a Pennsylvania limited liability company (f/k/a MTSM Acquisition LLC) (the "**Grantor**"), owns the trademarks listed on the annexed Schedule A, which trademarks are registered, to the extent indicated, in the United States Trademark Office (the "**Trademarks**");

WHEREAS, pursuant to the Security Agreement, the Grantor has granted to the Grantee, a mortgage on, pledge of and security interest in all right, title and interest of the Grantor in and to the Trademarks, the registrations or applications for registration thereof, and all proceeds thereof, including, without limitation, any royalties, claims for infringement and proceeds of sale or other disposition thereof (the "**Trademark Collateral**") to secure the payment and performance of the Obligations (as defined in the Credit Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Grantor does hereby grant to the Grantee a mortgage on, pledge of and security interest in the Trademark Collateral to secure prompt payment and performance of the Obligations.


