TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Agreement”) dated as of October 25, 2021, from CENTERFIELD CAPITAL PARTNERS III, L.P., as agent (the “Agent”), CCP III-A, L.P., a Delaware limited liability partnership (“CCP III”), and CCP III-SBIC, L.P., a Delaware limited liability partnership (“CCP SBIC”, and together with the Agent and CCP III, the “Grantees”, and each a “Grantee”), in favor of COSMIC PET LLC (F/K/A HYPER PET LLC), a Delaware limited liability company (“Cosmic Pet”), PAWS MERGER PARENT, LLC, a Delaware limited liability company (“Paws”), COSMIC PET BRANDS LLC (F/K/A HYPER PET BRANDS LLC), a Delaware limited liability company (“Cosmic Pet Brands”), OURPET’S COMPANY, a Colorado corporation (“OURPET’S”), VIRTU COMPANY, an Ohio corporation (“Virtu”), SMP COMPANY, INCORPORATED, an Ohio corporation (“SMP”), PET FUSION LLC, a New Jersey limited liability company (“PET FUSION”), and GRAC HOLDINGS LLC, a Delaware limited liability company (“GRAC”, and together with Cosmic Pet, Paws, Cosmic Pet Brands, OURPET’S, Virtu, SMP and PET FUSION, the “Grantors”, each individually a “Grantor”).

WITNESSETH:

WHEREAS, in connection with the those agreements listed on Schedule A hereto (as amended, supplemented or otherwise modified prior to the date hereof, the “Trademark Security Agreements”), each Grantor granted to the Agent, CCP III, and CCP SBIC, as applicable, a security interest in all of its right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreements) (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Trademark Security Agreements);

WHEREAS, the Trademark Security Agreements were recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the “USPTO”) as described on Schedule A hereto; and

WHEREAS, each Grantee now wishes to release its liens on, and security interests in, the Trademarks, including, without limitation, the trademarks set forth on Schedule B attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, each Grantee hereby states as follows:

1. Release of Security Interest. Each Grantee hereby terminates the Trademark Security Agreements and terminates, releases and discharges, and sets over and assigns to the Grantors, all of its security interest in the Trademarks, including any associated good-will of the business symbolized by the Trademarks, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof, and reassigns any and all right, title and interest that it may have in or to the Trademarks to the Grantors.
2. Recordation. Each Grantor or its authorized agent is authorized to record this Agreement with the USPTO.
3. Governing Law. This Agreement and the rights and obligations of the parties under this Agreement shall be construed in accordance with and governed by the laws of the State of Indiana.
4. Further Assurances. Each Grantee shall take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments),

reasonably requested by such Grantor, and at such Grantor's cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.
