## NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this “Notice”), dated as June 30, 2021, is filed by ZFT OPCO LLC, a Delaware limited liability company (“Grantor”), to provide notice of a security interest held by TEXAS CAPITAL BANK, NATIONAL ASSOCIATION, a national banking association (“Lender”) in certain trademarks owned by Grantor.

1. Grantor owns the trademarks and service marks set forth on Schedule 1 attached hereto, including the associated registrations and applications for registration set forth in Schedule 1 attached hereto (collectively, the “Trademarks”) and all goodwill of any business connected with the use of and symbolized thereby.

2. Borrower is party to, among other things, that certain (i) Credit Agreement dated as of the date hereof (as it may be amended, restated or modified from time to time, the “Credit Agreement”) by and between Borrower and Lender, and (ii) Pledge and Security Agreement dated as of the date hereof (as amended, amended and restated or otherwise modified from time to time, the “Security Agreement” and collectively with the Credit Agreement, the “Credit Documents”) in favor of Lender. Capitalized terms used in this Notice but not defined shall have the meanings set forth in the Credit Documents.

3. Pursuant to the Credit Documents, Grantor granted to Lender a valid, continuing security interest in certain intellectual property owned or hereafter acquired by Grantor (collectively, the “Trademark Collateral”).

4. Grantor has agreed to execute and deliver to Lender this Notice for purposes of filing the same with the United States Patent and Trademark Office (the “PTO”) to verify, confirm and evidence the security interest in the Trademark Collateral granted pursuant to the Credit Documents.

5. This Notice constitutes public notice of the grant and ongoing continuation of Lender’s security interest in and lien on Grantor’s right, title and interest in, to and under the Trademark Collateral.

6. Grantor hereby requests the PTO to file and record the same together with the annexed Schedule 1.

7. Grantor and Lender hereby acknowledge and agree that the security interest in the Trademark Collateral may only be terminated in accordance with the terms of the Credit Documents.
