**TERMINATION AND RELEASE OF
PATENT AND TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT (this "Termination") is dated as of October 28, 2021, and made by WELLS FARGO BANK, NATIONAL ASSOCIATION, having an office at 8601 N. Scottsdale Rd. Suite 240, Scottsdale, AZ 85253 ("Wells Fargo"), to ONTRAC LOGISTICS, INC. (f/k/a Express Messenger Systems, Inc.), a Delaware corporation (the "Company"), having an office at 2501 S. Price Road, Suite 201, Chandler, AZ 85286.

WHEREAS, Company and Wells Fargo entered into that certain Patent and Trademark Security Agreement, dated April 6, 2015 (as amended, the "Security Agreement"), in which a security interest was granted by Company in favor of Wells Fargo in certain Patents and Trademarks (as such terms are defined in the Security Agreement);

WHEREAS, the Security Agreement was originally recorded with the United States Patent and Trademark Office on May 21, 2015, at Reel 5521, Frame 0586; and

WHEREAS, Wells Fargo now desires to terminate and release the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Wells Fargo hereby states as follows:

1. Definitions. The terms "Patents" and "Trademarks", as used herein, shall have the meanings set forth in the Security Agreement and shall mean and include all of the Company's right, title and interest of every kind and nature as of the date hereof, including in the patents listed on Exhibit A attached hereto and the trademarks listed on Exhibit B attached hereto.

2. Release of Security Interest. Wells Fargo hereby terminates the Security Agreement, and terminates, releases and discharges its security interest in the Patents and Trademarks and reassigns to the Company all right, title and interest it may have in and to the Patents and Trademarks without recourse and without any representation or warranty.

Delivery of an executed signature page to this Termination by electronic image scan transmission shall be as effective as delivery of a manually executed counterpart hereof. Any signature to this Termination by facsimile or by email as a ".pdf" or ".tif" attachment shall be as effective as delivery of a manually executed counterpart of this Termination. It is understood and agreed that the words "execution", "signed", "signature", "delivery" and words of like import in or relating to this Termination shall be deemed to include any electronic signature, delivery or the keeping of any record in electronic form, each of which shall have the same legal effect, validity or enforceability as a manually executed signature, physical delivery thereof or the use of a paper-based recordkeeping system to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any similar state laws based on the Uniform Electronic Transactions Act.
