**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “*Release*”) is granted as of August 31, 2021 by **ANTARES CAPITAL LP** (as successor administrative agent to General Electric Capital Corporation, as successor administrative agent to GE Business Financial Services, Inc. (f/k/a Merrill Lynch Capital, a division of Merrill Lynch Business Financial Services Inc.)), as Administrative Agent for the Lenders referred to in the Credit Agreement referenced below (the “*Agent*”), in favor of **1105 MEDIA INC.**, a Delaware corporation (“*1105*”), **101COMMUNICATIONS LLC**, a Delaware limited liability company (“*101*”), **STEVENS PUBLISHING ACQUISITION CORPORATION**, a Delaware corporation (“*Stevens*”), **SECURITY EVENTS LTD.**, a Delaware corporation (“*Security Events*” and, collectively with 1105, 101, Stevens, Security Events and the other Credit Parties under the Credit Agreement, the “*Grantors*” and each, a “*Grantor*”).

**WHEREAS**, the Credit Parties, the financial institutions party thereto from time to time as Lenders and Agent are parties to that certain Second Amended and Restated Credit Agreement, dated November 30, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Credit Agreement*”); unless otherwise stated, terms used herein and not otherwise defined shall have the meanings ascribed to such terms in the Credit Agreement or the applicable Trademark Agreement (as defined below);

**WHEREAS**, the Credit Parties, including the Grantors, and the Agent have entered into that certain Security Agreement, dated as of April 7, 2006 (as amended, restated, supplemented, replaced, increased, refinanced or otherwise modified from time to time, the “*Security Agreement*”);

**WHEREAS**, the Grantors have executed and delivered the following Trademark Security Agreements (each a “*Trademark Agreement*” and collectively, the “*Trademark Agreements*”), pursuant to which the Grantors granted a security interest in all of their right, title and interest in, to and under the Trademark Collateral (as defined in each corresponding Trademark Agreement):

- (a) Trademark Security Agreement, dated as of April 7, 2006, among 1105, 101, Stevens and Agent, which was recorded with the United States Patent and Trademark Office on December 21, 2006, at Reel 003449 and Frame 0155;
- (b) Trademark Security Agreement, dated as of October 12, 2007, among 101 and Agent, which was recorded with the United States Patent and Trademark Office on November 19, 2007, at Reel 003664 and Frame 0242;
- (c) Trademark Security Agreement, dated as of December 22, 2006, among 1105, 101, Stevens and Agent, which was recorded with the United States Patent and Trademark Office on February 6, 2009, at Reel 003931 and Frame 0222;
- (d) Trademark and Security Agreement, dated as of December 1, 2011, among REMEDY HEALTH MEDIA, LLC, a Delaware limited liability company formerly known as Medizine, LLC, HC TECH, INC., a Delaware corporation and Agent, which was recorded with the United States Patent and Trademark Office on February 10, 2012,

at Reel 004715 and Frame 0180;

- (e) Trademark and Security Agreement dated as of June 21, 2013 and filed with the United States Patent and Trademark Office on June 21, 2013, at Reel 5053 and Frame 0639;
- (f) Trademark and Security Agreement, dated as of December 1, 2011, among REMEDY HEALTH MEDIA, LLC, a Delaware limited liability company formerly known as Medizine, LLC, HC TECH, INC., a Delaware corporation and Agent, which was recorded with the United States Patent and Trademark Office on February 10, 2012, at Reel 4715 and Frame 0237; and
- (g) Trademark Security Agreement dated as of November 30, 2012 and filed with the United States Patent and Trademark Office on November 30, 2012, at Reel 4910 and Frame 0519;

and

**WHEREAS**, the Agent (acting at the direction of the Required Lenders) now desires to terminate and discharge fully its interest in the Trademark Collateral described in each Trademark Agreement, including, for the avoidance of doubt, the Trademarks identified in Schedule A annexed hereto.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent does hereby release, terminate, cancel and discharge fully any and all liens and security interests it may have in and to the Trademark\_Collateral and hereby terminates and cancels the Trademark Agreements. If, and to the extent that the Agent has acquired any right, title and interest in, to, and under the Trademark Collateral, the Agent hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Company.

The Agent hereby agrees to take all further actions, and provide to the Company and its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Company, at the Company's sole cost and expense, to more fully and effectively effectuate the purposes of this Release; provided that any such further action shall be without representation or warranty by, or recourse to, the Agent or any Lender. The Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record this Release.

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.**
