**TRADEMARK SECURITY AGREEMENT**

This TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) dated as of October 28, 2021, is made by and between Mission BBQ Holdings, LLC, a Maryland limited liability company with an address at 7750 Governor Ritchie Highway, Glen Burnie, Maryland 21061 (together with its respective successors and permitted assigns, “**Parent**”), Mission BBQ I.P. Holdings, LLC, a Maryland limited liability company with an address at 7750 Governor Ritchie Highway, Glen Burnie, Maryland 21061 (together with its respective successors and permitted assigns, “**IP Holdings**”, and together with Parent, collectively and jointly and severally, the “**Grantors**”), and Manufacturers and Traders Trust Company, with an address at PO Box 1358, Buffalo, New York 14240, in its capacity as Administrative Agent for itself and the other Secured Parties (together with its successors and assigns in such capacity, the “**Administrative Agent**”). Capitalized terms not defined herein have the meanings set forth in the Credit Agreement or the Security Agreement (as such terms are defined herein).

WHEREAS, this Agreement will be filed with the United States Patent and Trademark Office to, among other things, indicate that the Administrative Agent is collateral assignee with respect to the Trademarks (as defined herein) listed on Schedule A hereto;

WHEREAS, Grantors are the owners of certain trademarks, including the applications and registrations thereof, together with the goodwill of the business connected with the use of and symbolized by the trademarks and all proceeds thereof, including, without limitation, any and all past, present, and future causes of action which may exist by reason of infringement thereof, set forth in Schedule A hereto (collectively, the “**Trademarks**”);

WHEREAS, Parent, the Administrative Agent, and the other parties thereto executed a Credit Agreement, dated as of the date hereof (as amended, restated, amended and restated, modified or supplemented from time to time, the “**Credit Agreement**”) and a Security Agreement

dated as of the date hereof (as amended, restated, amended and restated, modified or supplemented from time to time, the “**Security Agreement**”); and

WHEREAS, pursuant to the Credit Agreement and the Security Agreement, the Grantors granted and agreed to grant to the Administrative Agent a security interest in certain of their Collateral, including, without limitation, the Trademarks, to secure obligations owing to the Administrative Agent and certain other lenders.

NOW, THEREFORE, for good and valuable consideration, the Grantors hereby pledge and grant to the Administrative Agent a security interest and lien in and to the Trademarks to secure the Secured Obligations, subject to the terms of the Credit Agreement and the Security Agreement.


