**TERMINATION OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

This TERMINATION OF SECURITY INTEREST IN TRADEMARK RIGHTS, dated as of October 28, 2021, is made by Cantor Fitzgerald Securities, as Collateral Agent (the "Collateral Agent").

WHEREAS, GTAT Corporation, a Delaware corporation (the "Grantor"), granted to the Collateral Agent a security interest in certain personal property, including without limitation, a security interest in the Trademark Collateral (as defined below), pursuant to that certain Grant of Security Interest in Trademark Rights dated as of September 28, 2018 (as amended, the "Security Agreement" by the Grantor in favor of the Collateral Agent; all capitalized terms used herein and not defined shall have the meanings set forth in the Security Agreement);

WHEREAS, the notice of security interest was recorded at the United States Patent and Trademark Office on October 2, 2018 at Reel 6487, Frame 0660; and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such property, including without limitation, the Trademark Collateral as herein provided.

NOW, THEREFORE, for valuable consideration, the Collateral Agent hereby absolutely, unconditionally and irrevocably terminates and releases all liens and security interests granted to the Collateral Agent as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations in Grantor's right, title and interest in, to and under all of the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule A hereto. The foregoing release shall be without recourse, representation or warranty of any kind by the Collateral Agent.

The Collateral Agent hereby acknowledges that this document may be filed along with any other necessary documentation with the United States Patent and Trademark Office, to evidence the termination and release granted herein.

THIS TERMINATION OF SECURITY INTERESTS IN TRADEMARK RIGHTS AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REFERENCE TO CONFLICTS OF LAW PROVISIONS.
