TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release") is granted as of October 27, 2021 by CAMBRIDGE TRUST COMPANY (the "Grantee"), in favor of EVERTRUE, INC., a Delaware corporation (the "Grantor").

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks dated as of April 2, 2020 (the "Grant"), granting the Grantee a security interest in and lien on, among other things, certain trademarks and trademark applications referenced therein;

WHEREAS, the Grant was originally recorded in the Assignment Division of the United States Patent and Trademark Office ("USPTO") on April 2, 2020, at Reel 6907, Frame 0309;

WHEREAS, the Grantor has requested that the Grantee provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the trademarks and trademark applications as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

(i) releases and discharges, without any representation, warranty, recourse or undertaking by the Grantee, its liens and security interests in (A) the trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto (the "Marks"), (B) all proceeds and products of the Marks, (C) the goodwill of the businesses with which the Marks are associated, and (D) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same,

(ii) terminates the Grant in all respects and shall, upon the Grantor's reasonable request and at the Grantor's sole cost and expense, take all actions reasonably necessary to record with the USPTO or otherwise effectuate the purposes of this Termination and Release, and

(iii) authorizes the Grantor to record this Termination and Release with the Commissioner for Trademarks and any other applicable government officer.
