## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Trademark Release") is made as of October 28, 2021 by **BANK OF AMERICA, N.A.**, in its capacity as administrative agent and collateral agent (in such capacity, the "Grantee") for its own benefit and the benefit of the other Credit Parties under the Trademark Agreements (defined below), in favor of **DESTINATION XL GROUP, INC.**, a Delaware corporation having an office at 555 Turnpike Street, Canton, MA 02021 (the "Grantor").

WHEREAS, the Grantor granted a continuing security interest (the "Security Interest") to the Grantee in all of Grantor's Marks (as defined below) pursuant to that certain (a) Grant of Security Interest in United States Trademarks, dated as of May 24, 2018, by and between the Grantor and the Grantee (the "2018 Trademark Agreement"), (b) Supplement to Grant of Security Interest in United States Trademarks, dated as of September 5, 2019, by and between the Grantor and the Grantee (the "2019 Trademark Agreement"), and (c) Second Supplement to Grant of Security Interest in United States Trademarks, dated as of March 16, 2021, by and between the Grantor and the Grantee (the "2021 Trademark Agreement" and, together with the 2018 Trademark Agreement and the 2019 Trademark Agreement, collectively, the "Trademark Agreements");

WHEREAS, an executed copy of (a) the 2018 Trademark Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on May 24, 2018 at Reel 6336, Frame 0177, (b) the 2019 Trademark Agreement was recorded with the USPTO on September 5, 2019 at Reel 6737, Frame 0256, and (c) the 2021 Trademark Agreement was recorded with the USPTO on March 16, 2021 at Reel 7222, Frame 0104; and

WHEREAS, Grantor has requested that the Grantee execute this Trademark Release in order to terminate and release the Grantee's Security Interest in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged:

1. Definitions. All capitalized terms used herein and not otherwise defined herein shall have the same meaning as set forth in the applicable Trademark Agreement.

2. Release of Lien. The Grantee hereby terminates the Trademark Agreements and hereby terminates, cancels and releases without representation or warranty, the Security Interest and all other liens and security interests that it has in, to and under the United States trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications set forth on Schedule A attached hereto (the foregoing, collectively, the "Marks") including, without limitation, all of the goodwill of the business connected with the use of, and symbolized by the Marks, without recourse or representation or warranty, express or implied of any kind.

3. Further Assurances. The Grantee agrees to take all further actions and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance including the execution and delivery of all documents, make all filings, take all other actions reasonably requested by Grantor to evidence and record this Trademark Release, at Grantor's sole cost and expense, and without representation or warranty by the Grantee.

4. Governing Law. This Trademark Release shall be governed by, and construed in accordance with, the law of The State of New York.
