**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”), dated as of November 1, 2021, is made by U.S. BANK NATIONAL ASSOCIATION, as collateral agent (as successor in interest to Credit Suisse AG, Cayman Islands Branch and together with its successors and assigns in such capacity, the “Collateral Agent”) for the benefit of the Secured Parties (as defined in the Collateral Agreement (as defined below)), in favor of HARRAH’S BOSSIER CITY INVESTMENT COMPANY, L.L.C., a Louisiana limited liability company (the “Pledgor”).

**WITNESSETH**

WHEREAS, the Pledgor, each other pledgor identified in the Collateral Agreement and the Collateral Agent entered into that certain Collateral Agreement, dated as of December 22, 2017 (as supplemented by that certain Supplement No. 1, dated as of July 16, 2018 and that certain Supplement No. 2, dated as of July 20, 2020 and as it may be further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement, the Pledgor, CEOC, LLC, a Delaware limited liability company (“CEOC”), and the other pledgors party thereto executed and delivered to the Collateral Agent that certain Trademark Security Agreement, dated as of July 20, 2020 (the “Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office (“USPTO”) on November 12, 2020 at Reel/Frame No. 7104/0734 pursuant to which the Pledgor and CEOC granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all of the Pledgor’s and CEOC’s right, title and interest in or to any and all of the IP Collateral (as defined in the Trademark Security Agreement), including CEOC’s right, title and interest in and to the trademarks listed on Schedule I hereto (the “Specified Trademarks”);

WHEREAS, CEOC assigned all of its right, title and interest in and to the Specified Trademarks to the Pledgor pursuant to that certain Assignment of Trademark, dated as of October 7, 2020 and recorded with the USPTO on October 13, 2020 at Reel/Frame No. 7075/0970; and

WHEREAS, the Pledgor has requested that the Collateral Agent, and the Collateral Agent has agreed to, release its security interest in all right, title and interest in or to the Specified Trademarks in connection with the disposition of the Specified Trademarks.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in or to the Specified Trademarks, and agrees that all the security interest in the Specified Trademarks is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Specified Trademarks under the Collateral Agreement and the Trademark Security Agreement, and authorizes and requests that this Release be recorded with the USPTO at the Pledgor’s sole cost and expense.

This Release may be executed and delivered by facsimile or other means of electronic transmission and such transmission shall constitute an original for all purposes.

This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated


hereby shall be construed in accordance with and governed by the law of the state of New York, without reference to its conflict of laws principles.

U.S. BANK NATIONAL ASSOCIATION is executing this Release solely in its capacity as successor Collateral Agent under the Collateral Agreement, and in acting hereunder, shall be entitled to all of the rights, privileges, immunities and indemnities granted to the Collateral Agent in the Collateral Agreement as if such rights, privileges, immunities and indemnities were set forth herein.
