TRADEMARK ASSIGNMENT

ASSIGNOR shall sign all papers and documents and otherwise do all acts reasonable, necessary and desirable in connection therewith at the cost and expense of ASSIGNEE, its legal representatives, successors and/or assigns. In addition, any continued use by ASSIGNOR of the Trademark shall inure to the benefit of the ASSIGNEE.
