**NUNC PRO TUNC TRADEMARK ASSIGNMENT AGREEMENT  
(UNITED STATES)**

This Agreement is effective as of, and confirmatory of an assignment on, January 1, 2019.

**WHEREAS**

**CROWN RESTAURANT EQUIPMENT LTD.**, a corporation organized under the laws of Alberta, Canada, having a registered head office at 5307 4 Street SE, Calgary, AB T2H 1K6 (hereinafter "**Assignor**" or "**Crown Restaurant**")

**WHEREAS**

**NICK POULOS FAMILY TRUST**, a legal entity and Alberta trust, whose address for correspondence is that of one of the trustees, namely Nick Poulos, whose address is 5307 4 Street SE, Calgary, AB T2H 1K6 (hereinafter "**Assignee**" or "**Poulos Family Trust**")

is desirous of confirming its acquisition via said assignment of all rights in the United States in the trademarks identified and listed in Schedule "A" hereto from Crown Restaurant;

**NOW THEREFORE**, in consideration of Two Dollars (\$2.00) paid by the Assignee to the Assignor, as well as for other good and valuable consideration, the receipt of which is hereby acknowledged by the Assignor, the Assignor does hereby confirm its sale, assignment, and transfer over to the Assignee, its successors and assigns, effective as of January 1, 2019, of the whole right, title and interest of the Assignor in the United States in and to:

1. the trademarks listed in Schedule "A" hereto, including any pending applications and current and future registrations; and
2. any and all common law rights in the trademarks listed in Schedule "A" in the United States that Crown Restaurant or its predecessors-in-title may have acquired by virtue of use and adoption of the trademarks listed in Schedule "A" hereto *inter alia* in association with the goods identified therein, together with all the goodwill in Assignor's business in the United States relating to the trademarks listed in Schedule "A";

the same to be held and enjoyed by the Assignee as fully and effectively as the same would have been enjoyed by the Assignor if this assignment and transfer had not been made.

The Assignor agrees to do, and as agreed to act, with reasonable diligence so as to do all such things and provide all reasonable assurances as may be required to consummate the transactions contemplated hereby, and Assignor shall provide Assignee with such further documents or instruments required by Assignee as may be reasonably necessary or desirable to effect the purpose of this Agreement and carry out its provisions, including the registration of this assignment with the United States Patent and Trademark Office.


Without limiting the foregoing, the Assignor agrees to execute and deliver, at the request of the Assignee, all papers, instruments, and assignments and to perform any other reasonable acts the Assignee may require in order to confirm the transfer of the Assignor's right, title and interest in and to the trademarks in Schedule "A" to the Assignee, and/or to permit recordal of this Assignment document

or such other assignment document with the United States Patent and Trademark Office and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of the Assignor.
