TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of November 1, 2021, and made by **BMO HARRIS BANK, N.A.**, as administrative agent (in such capacity, the "Administrative Agent"), to **IMA FINANCIAL GROUP, INC.**, a Kansas corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of April 30, 2021, made by the Grantor in favor of the Administrative Agent (the "Security Agreement"), a security interest was granted by the Grantor to the Administrative Agent in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the Trademark division of the United States Patent and Trademark Office on May 4, 2021, at Reel/Frame 7279/0192;

WHEREAS, Administrative Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Administrative Agent hereby states as follows:


1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Administrative Agent in the Intellectual Property, in each case without representation, recourse or warranty whatsoever.
