TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this “*Assignment*”) is made as of September 29, 2021, by and among (i) Citrin Cooperman & Company, LLP, a New York registered limited liability partnership (“*AttestCo*”) and (ii) Citrin Cooperman Advisors LLC, a Delaware limited liability company (“*AdvisoryCo*”). *AdvisoryCo* and *AttestCo* are sometimes collectively referred to herein as the “Parties” and individually as a “Party.”

RECITALS

WHEREAS, pursuant to the terms and conditions of the Assignment, Assumption and Contribution Agreement dated September 29, 2021, by and among *AdvisoryCo*, *AttestCo*, Holdings and Intermediate (the “*Contribution Agreement*”), *AttestCo* assigned, conveyed, transferred and delivered all of the Assets (including the trademarks set forth on Schedule A hereto, the “*Assigned IP Assets*”) owned by *AttestCo* (excluding the Excluded Assets) to *AdvisoryCo*;

WHEREAS, each capitalized term used but not otherwise defined in this Agreement has the meaning ascribed to it in the Contribution Agreement;

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, *AttestCo* and *AdvisoryCo* agree as follows:

1. Assignment. Subject to the terms and conditions of the Contribution Agreement, *AttestCo* hereby irrevocably and unconditionally confirms the assignment, conveyance, transfer and delivery to *AdvisoryCo*, and *AdvisoryCo* hereby confirms the acceptance, of all of *AttestCo*’s rights, title and interest in and to, any and all of the Assigned IP Assets, together with (i) any and all goodwill associated therewith and symbolized thereby, (ii) all rights therein provided by international treaties or conventions, (iii) all reissues, extensions and renewals of any of the foregoing and (iv) all rights to sue and recover damages for past, present and future infringement or other violation thereof or conflict therewith.

2. Further Assurances. *AttestCo* hereby covenants and agrees to execute such further and confirmatory assignment in recordable form as *AdvisoryCo* may reasonably request to the extent necessary to vest record title of the Assigned IP in *AdvisoryCo*. *AttestCo* further authorizes and requests the Commissioner of Trademarks of the United States, and the corresponding entities or agencies in any applicable foreign jurisdictions, to record *AdvisoryCo* as the owner of the Assigned IP, as *AdvisoryCo* of the entire right, title and interest in, to and under the same, for the sole enjoyment of *AdvisoryCo* and its successors and assigns.

3. Contribution Agreement Controlling. This Assignment is intended to evidence the consummation of certain transactions completed in the Contribution Agreement. This Assignment is made without representation or warranty, except as and to the extent provided in the Contribution Agreement. To the extent that any provision of this Assignment is inconsistent or conflicts with the Contribution Agreement, the provisions of the Contribution Agreement shall control. Nothing contained in this Assignment shall be deemed to supersede, enlarge, limit or otherwise modify any of the obligations, agreements, covenants, representations or warranties of the parties contained in the Contribution Agreement.

4. Miscellaneous. This Assignment is binding upon, and inures to the benefit of and is enforceable by *AttestCo* and *AdvisoryCo* and their respective successors and permitted assigns. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
