RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY is made as of October 29, 2021, by CAPITAL ONE, NATIONAL ASSOCIATION, as Collateral Agent (the “Collateral Agent”), in favor of ENVYSION, INC., a Delaware corporation (“Envysion”), ENVYSION INTERMEDIATE CORP., a Delaware corporation (“Holdings”), and ENVYSION HOLDINGS, L.P., a Delaware limited partnership (“Parent” and together with Envysion and Holdings, individually and collectively, the “Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the IP Security Agreement (as defined below), whether directly therein or by reference to another agreement.

WITNESSETH:

WHEREAS, Envysion, Holdings and the Collateral Agent are parties to that certain Intellectual Property Security Agreement, dated as of January 29, 2013, which was duly recorded with the United States Patent and Trademark Office (the “USPTO”) as of February 6, 2013 at Reel 029768 and Frame 0838 and Reel 004957 Frame 0013 (as supplemented by (i) that certain Intellectual Property Security Agreement Supplement, dated as of September 10, 2015, executed by Envysion and Holdings in favor of the Collateral Agent and duly recorded with the USPTO as of September 15, 2015 at Reel 036567 and Frame 0734 and on September 21, 2015 at Reel 5626 and Frame 0292 and that certain Intellectual Property Security Agreement Supplement, dated as of March 6 2017, executed by Envysion in favor of the Collateral Agent and duly recorded with the USPTO as of March 6, 2017 at Reel 041895 and Frame 0151 and Reel 006002 Frame 0189, the “IP Security Agreement”);

WHEREAS, Grantor has requested that the Collateral Agent release its continuing security interest in the Intellectual Property and reassign any and all rights in the same to Grantor; and

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the security interest in the Intellectual Property.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. The Collateral Agent hereby releases the security interest in all of Grantor’s right, title and interest in and to the following:

- a. all of its Intellectual Property to which it is party, including the United States intellectual property referred to on Schedule 1;
- b. all divisionals, continuations, continuations-in-part, reissues, reexaminations, or extensions of the foregoing; and
- c. all products and proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future infringement of any Intellectual Property, including, the right to receive damages, or right to receive license fees, royalties, and other compensation under any intellectual property license.

2. The Collateral Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent’s right, title and interest in and to the Intellectual Property and hereby terminates the IP Security Agreement. The

Collateral Agent authorizes the recordation of this Notice of Release of Security Interest in Intellectual Property with the USPTO, at Grantor's expense.
