TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement") is between Danielle Goldie Cone (the "Assignor"), a Washington resident with an address of 122 E. 2. **Consideration.** As evidenced by the Purchase and Sale Agreement (PSA) between Assignor and Ada's Discovery, LLC, dated May 17, 2020, the Assignee desires to acquire from the Assignor all of Assignor's right, title and interest in and to the Trademark registration, together with the benefit of any use of the Trademark by the Assignor, and the goodwill of the business relations to the Trademark and to the wares or services associated with it, to hold unto the Assignee absolutely.

Now therefore, in consideration of the payment made in the aforementioned PSA and for good and valuable consideration, the receipt, sufficiency and adequacy of which is hereby acknowledged, the Assignor and the Assignee hereby agree as follows:

3. **Trademark Assignment.** The Assignor hereby sells, transfers and assigns to the Assignee, its successors and assigns, the Assignor's entire right, title and interest in and to the Trademark application and/or registrations, together with (i) the benefit of any use of the Trademark by the Assignor (ii) the goodwill of the business relations to the Trademark and to the wares or services associated with it, (iii) all income, royalties and damages hereafter due or payable to Assignor with respect to the Trademark(s) to hold unto the Assignee absolutely.
