**TERMINATION AND RELEASE OF SECURITY  
INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release") dated as of November 2, 2021, from 2647462 Ontario Inc., an Ontario corporation (the "Lender"), to Real Estate Equity Exchange, Inc., a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights, effective as of November 4, 2019, by the Grantor in favor of the Lender (as the same may have been amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), the Grantor granted to the Lender a security interest in the Trademark Collateral as defined therein;

WHEREAS, the Trademark Security Agreement was recorded in the Assignment Recordation Branch of the United States Patent and Trademark Office on November 7, 2019 at Reel 6790, Frame 0973; and

WHEREAS, the Lender now desires to evidence the release of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Lender hereby agrees and acknowledges as follows:


1. Definitions. Unless otherwise defined herein, terms used in this Release have the meanings provided in Trademark Security Agreement.

2. Release of Security Interest. The security interest and right of setoff of the Lender in or against the Trademark Collateral (including, without limitation, Trademark Collateral listed on Schedule A hereto) created or arising under the Trademark Security Agreement, the Security Agreement or any other Loan Document are hereby terminated, released and discharged. The Lender understands and agrees that this Release may be recorded by or for the Grantor with the United States Patent and Trademark Office.
