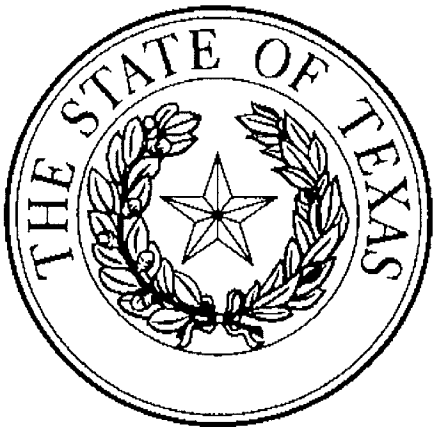

FIRST: The name of the filing entity is 4-Web, Inc.


SECOND: The type of filing entity is a corporation organized under the laws of the State of Texas.
