## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of November 2, 2021, by **SILICON VALLEY BANK**, a California corporation, in its capacity as administrative agent and collateral agent for the Lenders (as defined in the IP Security Agreement described below) (in such capacity, "**Agent**") in favor of **PATIENTPOP, INC.**, a Delaware corporation ("**Grantor**").

### Recital

WHEREAS, Grantor granted to Agent a security interest in Grantor's intellectual property, including without limitation, trademarks described on Exhibit A attached hereto (collectively the "**Intellectual Property**") under that certain Intellectual Property Security Agreement dated as of July 20, 2021 (the "**IP Security Agreement**") and recorded on July 21, 2021, reel/frame 7360/0680, with the U.S. Patent and Trademark Office as set forth on Exhibit A.

WHEREAS, Grantor has requested, and Agent has agreed to release its security interest in the Intellectual Property and terminate the IP Security Agreement.


### Agreement

Now, therefore, Agent agrees that it terminates and releases its security interest in the Intellectual Property, terminates the IP Security Agreement, and reassigns to Grantor, without warranty or recourse, all interest of Agent in the Intellectual Property.
