NOTICE OF TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS

This NOTICE OF TERMINATION AND RELEASE dated as of September 16, 2021, from U.S. BANK NATIONAL ASSOCIATION, as collateral agent (the "Agent") to BLUE YONDER GROUP, INC. (formerly known as JDA Software Group, Inc.) (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement dated as of July 31, 2020 (as amended, amended and restated, supplemented or otherwise modified from time to time), made by the Grantor in favor of the Agent (the "Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of July 31, 2020 among the Agent and Grantor (the "Trademark Security Agreement"), Grantor, by reference to the Security Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 3, 2020, at Reel 007013 and Frame 0447; and


WHEREAS, the Security Interest was terminated and released on September 16, 2021, in accordance with Section 6.11 of the Security Agreement;

NOW, THEREFORE, at the request of Grantor and following the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the adequacy of which is hereby acknowledged, and upon the terms set forth in this Notice of Termination and Release, the Agent hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule 1 hereto). The term "Trademark" shall have the meaning provided by reference in the Security Agreement and the Trademark Security Agreement.
2. Release of Security Interest. The Agent hereby acknowledges that the Security Interest in the Trademark Collateral has been terminated, released and discharged in accordance with Section 6.11 of the Security Agreement, and any right, title or interest of the Agent in such Trademark Collateral has therefore ceased and become void.
3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
