RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 1, 2021 (this “Release”), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as administrative agent and collateral agent (in such capacity, the “Agent”), in favor of APG MEDIA OF THE ROCKIES, LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Grantor and the Agent entered into that certain Trademark Security Agreement, dated as of July 2, 2018 (the “Trademark Security Agreement”), pursuant to which the Grantor pledged and granted to the Agent a security interest in and to all of its right, title and interest in, to and under the IP Collateral (as defined therein), including without limitation, the trademark registrations listed on Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 7, 2019 at Reel 6518 and Frame 0228; and

WHEREAS, Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the IP Collateral.


NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interests created under the Trademark Security Agreement in the IP Collateral, (b) discharge and release its security interest in and to the IP Collateral, and (c) reassign any and all rights, title and interest it has in the IP Collateral to the Grantor.

THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT UNDER THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO ITS CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF ANY OTHER LAW.
