**SECOND.** The jurisdiction immediately prior to filing this Certificate is Oregon.

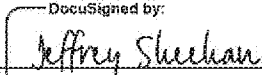
**THIRD.** The date the Oregon Corporation first formed is February 13, 1981, under the name Johnstone Supply, Inc.

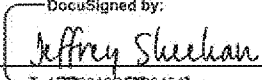
