TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 1, 2021 (this “Release”), is made by Madryn Health Partners, LP, a Delaware limited partnership, as administrative agent for the Secured Parties (“Administrative Agent”), in favor of Leiters, Inc., a Delaware corporation (“Company”).

WHEREAS, pursuant to that certain Security Agreement dated as of July 22, 2019, (as the same may be amended, modified, restated or supplemented from time to time, the “Security Agreement”), by and among the Company, other Grantors thereto, and the Administrative Agent, the Company granted to the Administrative Agent a continuing security interest in and lien upon, the trademarks, trademark licenses, and trademark applications set forth on Schedule 1 attached hereto to the Administrative Agent for the ratable benefit of the Secured Parties.

WHEREAS, pursuant to the Security Agreement, Company executed and delivered to Administrative Agent, for the benefit of the Secured Parties, a Notice of Grant of Security Interest in Trademarks (“Notice”).

WHEREAS, the Notice was recorded at the United States Patent and Trademark Office (“USPTO”) on June 3, 2020, at Reel 006952, Frame 0259.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of the Secured Parties, and Company agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in and continuing lien upon the trademarks, trademark licenses, and trademark applications listed on Schedule 1 attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Company’s expense.

SECTION 3. Choice of Law. This Release and obligations of the parties hereunder, and all of their successors, assigns, and transferees, shall be governed by and construed in accordance with the laws of the State of New York.
