**TERMINATION AND RELEASE
OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the “Release”) is executed as of November 1, 2021, by FIFTH THIRD BANK, NATIONAL ASSOCIATION, as administrative agent (“Administrative Agent”) in favor of LIGNETICS OF GREAT LAKES, LLC (“Grantor”). Unless otherwise indicated, capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Security Agreement as referred to below.

WHEREAS, Grantor and Administrative Agent executed a certain Trademark Security Agreement dated as of March 31, 2021 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”) pursuant to which Grantor granted to Administrative Agent, for the ratable benefit of the Credit Parties, a continuing security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined therein) (the “Security Interest”), including, without limitation, the Trademarks listed on Exhibit A hereto;

WHEREAS, the Security Agreement was recorded with the Patent and Trademark Office (“USPTO”) on April 27, 2021 at Reel 7272 and Frame 0432;


WHEREAS, Administrative Agent has agreed to release, and terminate its Security Interest in, the Trademark Collateral and assign and transfer to Grantor all deeds, assignments and other instruments as may be necessary or proper to reassign and reconvey to Grantor the entire right, title and interest to the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Administrative Agent hereby releases and terminates the Security Agreement and assign and transfers to Grantor, without representation, warranty or recourse, all of Administrative Agent’s right, title and interest in and to the Trademark Collateral (including, without limitation, the Trademarks listed on Exhibit A hereto), effective as of the date set forth above.
