## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 27, 2021 (this “Release”), is made by BMO Harris Bank N.A., as Administrative Agent (“Administrative Agent”) in favor of Hinsdale Animal Cemetery & Crematory, Inc., an Illinois corporation (“Grantor”).

**WHEREAS**, pursuant to that certain Pledge and Security Agreement dated as of April 1, 2019 (as amended, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among Grantor, Administrative Agent, and other parties thereto, Grantor granted to Administrative Agent, for the benefit of the Credit Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in and to all Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, the “Trademark Collateral”); and

**WHEREAS**, pursuant to the Security Agreement, Administrative Agent’s security interest in the Trademark Collateral was recorded with the United States Patent and Trademark Office (“USPTO”) on December 21, 2020 at Reel 7141 Frame 0762.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Credit Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of the Credit Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, any and all right, title and interest of Grantor in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.


