### TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination"), dated as of November 4, 2021, is made by the Governor and Company of the Bank of Ireland, in its capacity as the collateral agent (the "Collateral Agent") in favor of Rain Agency, Inc. (f/k/a Respond2 Communications, Inc.), Rain Agency, LLC (f/k/a CMedia Services LLC), Respond 2 Entertainment, LLC and Rain Unlimited, LLC (f/k/a Respond 2 LLC) (collectively, the "Grantors"). Capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Intellectual Property Security Agreement (defined below).

**WHEREAS**, each Grantor has granted to the Collateral Agent a security interest in and to all of such Grantor's Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement) pursuant to that certain Intellectual Property Security Agreement, dated as of May 15, 2013, by Grantors, in favor of the Collateral Agent (the "Intellectual Property Security Agreement");

**WHEREAS**, the Collateral Agent has agreed to terminate and release its security interest in the Intellectual Property Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby:

- (a) terminates, relinquishes, releases and discharges all liens and security interests granted to the Collateral Agent in the Intellectual Property Collateral;
- (b) reassigns, transfers, and conveys to the applicable Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Intellectual Property Collateral;
- (c) terminates and cancels the Intellectual Property Security Agreement; and
- (d) agrees that it shall, at any Grantor's sole cost and expense, execute all other documents and do all other acts in writing reasonably requested by any Grantor and reasonably necessary to relinquish, confirm, effectuate or record this Termination and hereby authorizes each Grantor or its designee to record with the USPTO this Termination.

This Termination shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
