**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**, dated as of November 5, 2021 (“Release”), is made by Wells Fargo Bank, National Association, as Administrative Agent (“Administrative Agent”), in favor of WeGoLook, LLC, an Oklahoma limited liability company (“Pledgor”).

WHEREAS, pursuant to that certain Amended and Restated Pledge and Security Agreement dated as of October 11, 2017 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”) by and among the Pledgor, Administrative Agent, and others party thereto and the Grant of Security Interest in Patents and Trademarks dated as of October 11, 2017 (“IP Grant”) by and among the Pledgor and Administrative Agent, Pledgor granted to the Administrative Agent a security interest in all of its right, title and interest in and to the Trademarks and the Patents, and Trademark registrations, and the use thereof, together with all proceeds and products thereof and the goodwill of the business symbolized by the Trademarks and Patents (collectively, the “IP Collateral”); and

WHEREAS, the IP Grant was recorded at the United States Patent and Trademark Office (“USPTO”) on October 16, 2017 at Reel 6182 Frame 0973.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent and Pledgor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or IP Grant.

SECTION 2. Termination and Release. Administrative Agent hereby:

(a) terminates the IP Grant;

(b) terminates, cancels, forever discharges, and releases the security interest in Pledgor’s right, title and interest in, to and under the IP Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(c) authorizes the recordation of this Release with the USPTO at Pledgor’s expense.

SECTION 3. Further Assurances. Administrative Agent, at Pledgor’s expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the IP Collateral, Administrative Agent will, at Pledgor’s expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Administrative Agent has caused this Termination and Release of Security Interest in Patents and Trademarks to be duly executed as of the date first set forth above.


