**RELEASE OF TRADEMARK SECURITY INTEREST**

Tops Markets, LLC, a New York limited liability company (“**Assignor**”), previously entered into that certain (i) Guarantee and Security Agreement (Second Lien Notes), dated as of November 19, 2018 (as the same may be amended, modified, extended or restated from time to time, the “**Security Agreement**”), by and among Assignor and the other Guarantors (as defined therein) party thereto in favor of Ankura Trust Company, LLC, as Trustee and Collateral Agent (the “**Collateral Agent**”) for the holders of the Secured Obligations referenced therein, and (ii) that certain related Notice of Security Interests (Second Lien) in Trademarks, dated as of November 19, 2018, made by Assignor in favor of the Collateral Agent, recorded in the U.S. Patent and Trademark Office (the “**PTO**”) on November 21, 2018, Reel 006487, Frame 0601 (the “**Notice of Grant of Security Interest**”). Pursuant to the terms of the Security Agreement, the Collateral Agent was granted a security interest in the trademark(s) described on Schedule A attached hereto and made a part hereof (the “**Marks**”).

The Collateral Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges its security interest in the Mark(s). Any right, title or interest of the Collateral Agent in such Mark(s) shall hereby cease and become void.


